DOG REGISTRATIONS

Just a reminder that your dog(s) need to be registered by January 31st, 2009. Please bring in your Rabies certificate and a certificate of Spay or Neutering if the dog is altered. As of February 1st there will be a \$25.00 late fee per dog in addition to the registration fee

Registration fees are as follows:

Neutered or Spayed - \$6.00 Unaltered - \$11.00

VEHICLE REGISTRATIONS

When <u>re-registering</u> a motor vehicle, you must show proof of insurance in the State of Maine, provide the mileage on the vehicle.

When registering a <u>NEW</u> vehicle, you must provide insurance information, bill of sale, title or title application.

Applicants must provide positive identification and fully complete the shellfish license application prior to issuance.

PARKING ENFORCEMENT


Parking regulations are part of the Coastal Waters Ordinance adopted by the Town of Chebeague Island. Beginning December 15th, 2009 those regulations regarding the length of time your vehicle may be parked on the Stone Wharf and Wharf Road will be more strictly enforced. This is necessary due to the amount of vehicles that have been parked for long periods of time. Parking is allowed only for a period of 24 hours, and will be strictly enforced.

Plowing of Snow into or across Town Roads

It is wintertime and many people are occupied with issues related to snow removal. When we receive a large volume of snow it can present problems for homeowners, as they try to clear their driveways. The Town of Chebeague Island is concerned with preventing and removing obstructions, such as snow, from accumulating on Town Roads. In fact, a number of statutes provide for the Town to deal with obstructions.

Title 29-A (Motor Vehicles), Chapter 21, Subchapter III § 2396 prohibits any person from placing in the public way snow or slush that has not accumulated there naturally.

Please do not shovel, blow snow, plow or have your driveway plowed into or across the road. This is prohibited by law, and can cause a serious hazard. If possible it is best to place snow on the side of your driveway opposite (downstream from) the direction traveled by the plow. Snow on that side of your driveway will be carried by the plow away from your driveway rather than back into your driveway.
